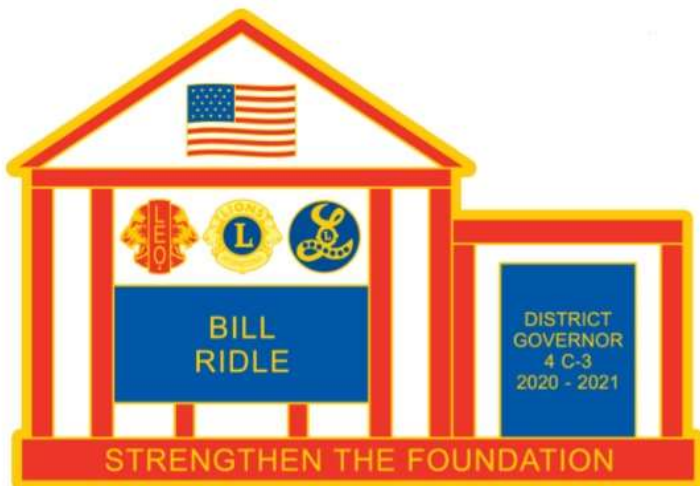

PROTOCOL

DISTRICT GOVERNOR'S OFFICIAL VISITATION

The Club President shall consider that these procedures are followed when the District Governor or any other Lions International Dignitary makes an official visit. The preliminary Governor's visitation schedule is listed in this directory. The Club President should act as the official greeter to welcome the District Governor and visitors.

If a head table is used, try to have it arranged as outlined below. Assist the District Governor's party in finding their places at the head table or assign hosts to do so. Two-sided place cards are very helpful. It is up to the club's discretion to pay for any meals for any other officials or visitors at any time.

INTRODUCTIONS: As President, you shall open your meeting under your own Club rules and regulations. When it is time for the official presentation of the District Governor, it will be your responsibility to introduce your Club's Zone Chair, who will introduce the Region Chair, who will introduce the District Governor will introduce other Cabinet members who are in attendance. When spouses are present, they should be introduced with the Lion member (i.e. District Governor John doe and his wife, Jane).

REMEMBER, the District Governor is an official representative of Lions Clubs International, and as such, should be given a **STANDING RECOGNITION** as a matter of courtesy to the office presented. Upon closing remarks, the District Governor, you will take over the meeting as President and give appropriate thanks to visiting guests, Cabinet officers and any personal recognition you desire.

Dr. Jung-Yul Choi of Busan, Republic of Korea was elected to serve as President of Lions Clubs International at the association's 102nd International Convention held at Milan Italy, July 5th through July 9th, 2019.

A member of the Busan Jae-il Lions Club since 1977, President Choi has held many offices within the associations, including club president, cabinet secretary, district governor and international director. He also served numerous times as a DGE Group Leader and served on 11 committees as a member of the International Board of Directors. In addition, he was a chairperson of the 39th OSEAL Forum in 2000 and a host committee chairperson at the 95th Lions International Convention in Busan in 2012, the largest convention ever held in Lions history.

HELEN KELLER

Born in Tuscumbia, Alabama, USA, in 1880, Helen Keller developed a fever at 18 months of age that left her blind and deaf.

With the help of an exceptional teacher, Anne Mansfield Sullivan of the Perkins School for the Blind, Helen Keller learned sign language and braille. A few years later, she learned to speak. As an adult she became a tireless advocate for people with disabilities. And in 1925, she attended the Lions Clubs International Convention and challenged Lions to become "knights of the blind in the crusade against darkness."

The Lions accepted her challenge and our work ever since has included [sight programs](#) aimed at preventable blindness.

HELEN KELLER DAY

In 1971, the Board of Directors of Lions Clubs International declared that June 1 would be remembered as Helen Keller Day. Lions around the world implement sight-related service projects on Helen Keller Day.

Some Helen Keller quotes

- When one door of happiness closes, another opens; but often we look so long at the closed door ...
- "I would rather walk with a friend in the dark, than alone in the light." — Helen Keller.
- "The best and most beautiful things in the world cannot be seen or even touched. They must be felt ...
- "Life is either a daring adventure or nothing at all." — Helen Keller, The Open Door.
- "We could never learn to be brave and patient, if there were only joy in the world."
- "Character cannot be developed in ease and quiet. Only through experience of trial and suffering can the soul be strengthened, vision cleared, ambition inspired, and success achieved."

MELVIN JONES Story



Melvin Jones was a dreamer, a doer, and a pragmatist. He was an energetic, extroverted salesman who in private hours would reread Shakespeare. What better man to found the world's largest association of service clubs?

The Lions International Board of Directors officially designated Jones as the founder of Lions Clubs in 1958—more than four decades after Lions Clubs held its first meeting. But no matter what his official title, Jones' impact on the Lions has been far-reaching. He provided the leadership, the organizational ability, the tenacity, and the muscle necessary to establish the foundation for Lions Clubs International to become what it is today.

Jones was born on Jan. 13, 1879, at Fort Thomas, Arizona, a remote U.S. Army cavalry post where his father was a scout for the Army. At age 7, Jones' family moved east and settled in Illinois. Gifted with a fine tenor voice, he considered making his career in music. Instead, he became an insurance salesman.

By 1913, Jones had formed his own insurance agency in Chicago. When he joined a networking luncheon club for businessmen in Chicago called the Business Circle, he quickly took the lead in recruiting new members and persuading backsliders to rejoin. But something about the club's business-only focus did not square with Jones' different, larger vision.

"What if these men who are successful because of their drive, intelligence, and ambition, were to put their talents to work improving their communities?" Jones asked. He saw a new kind of club with the desire to help others.

As Business Club secretary, Jones, with help from his wife—the championship golfer Rose Amanda Freeman—wrote scores of letters to clubs nationwide inviting them to take up his idea for a service-centered organization. Businessman

interested in membership convened in Chicago, Illinois, and on June 7, 1917, Lions Clubs International was born.

Later that year, at Lions' inaugural convention in Dallas, Texas, Jones was elected secretary-treasurer, a title he would hold for many years. Eventually, the board bestowed upon Jones the title of secretary general for life.



Jones was a prolific writer who could be clear and forceful on some occasions, and sentimental the next. His hand can be seen in founding documents like the Lions Clubs Objects and Code of Ethics. His columns in LION Magazine, which are still quoted today, helped articulate the organization's principles and values.

He also loved aphorisms. Never one to sugarcoat the truth, Jones had one favorite saying neatly framed in his office: "Truth and roses have thorns about them."

Jones gave up the insurance business in 1926 to become Lions' de facto CEO and global goodwill ambassador. He played both roles brilliantly building and managing an expanding headquarters operation and travelling constantly for club visits and speaking engagements. The pace never stopped.

DR. MAUREEN POWERS – LEADERSHIP



Maureen Powers is a neuroscientist who studies the visual system. She grew up in Alameda and earned her bachelor's degree from Cal (Go Bears!). She then moved to the University of Michigan, where she did her PhD in Psychobiology followed by postgraduate research in Ophthalmology. Moving on to the University of Washington, Lion Mo did additional postgraduate work in Vision Science, and then went to Nashville as Professor of Psychology in Neuroscience at Vanderbilt University. She stayed at Vanderbilt for 20 years, where she taught university classes and did research on vision. Dr. Mo also founded the cross-disciplinary Vanderbilt Vision Research Center, an accomplishment for which she was honored in 2015.

She happily returned to the Bay Area to marry Lion Gary Miner in 1999. Gary and Mo joined the Crockett Lions Club in 2000. They are now active members of the Oakland Montclair Lions Club (where she is Club Secretary) and Associate Members of the Crockett Club. Lion "Dr" Mo has served the District as Sight Conservation Chair; she is Past President, Secretary, and Tail Twister of the Crockett Lions; and she currently serves as President of the Board of Directors of the Lions Vision Resource Network – formerly Lions Center for the Blind in Oakland.

She is a proud recipient of the Lions Clubs International President's Award for Distinguished Service, and last year she was awarded a Helen Keller Fellowship by the Montclair Lions Club.

Through your membership, you will help our club reach out to people in need in our community, and throughout the world.

3) Lions Clubs International History You are becoming part of a distinguished service history that dates back to 1917, when Lions Clubs International began as the dream of Chicago insurance man Melvin Jones. He believed that local business clubs should expand their horizons from purely professional concerns to the betterment of their communities and the world at large. Jones' own group, the Business Circle of Chicago, agreed.

After contacting similar groups around the country, an organizational meeting was held on June 7, 1917, at the LaSalle Hotel in Chicago, Illinois, USA. The new group took the name of one of the groups invited, the "Association of Lions Clubs," and a national convention was held in Dallas, Texas, USA in October of that year. Thirty-six delegates representing 22 clubs from nine states were in attendance. The convention began to define what the association was to become. A constitution, by-laws, objects and code of ethics were approved. Since that humble beginning, Lions club members have volunteered their time and talents to meet needs wherever they exist. Lions are especially dedicated to serving the blind and visually impaired, a commitment made after Helen Keller challenged our members to become her "knights of the blind in the crusade against darkness" during the 1925 convention in Cedar Point, Ohio, USA. Our motto, "We Serve" perfectly exemplifies the dedication to helping those in need felt by Lions worldwide. 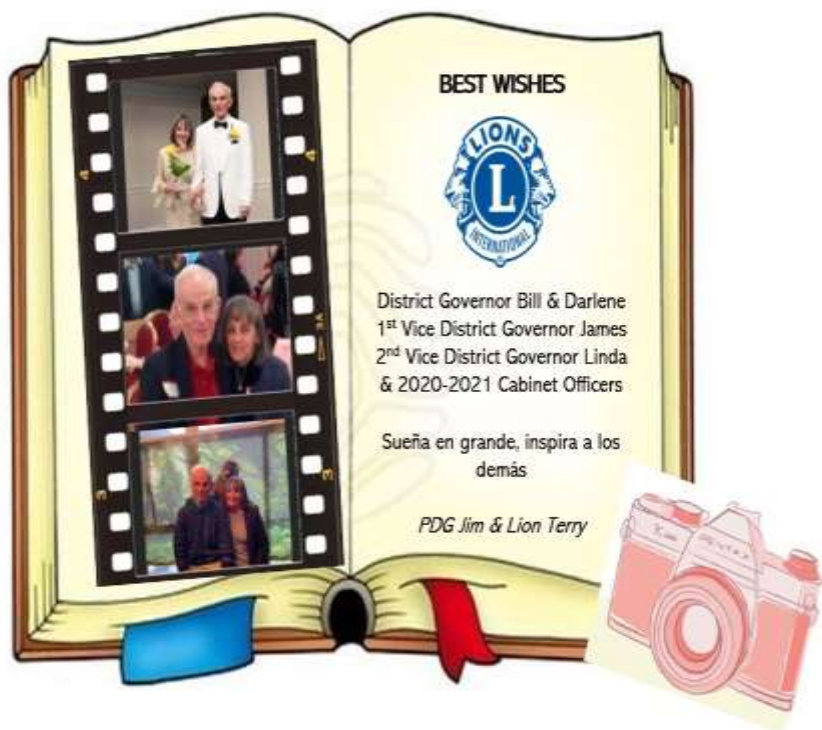

WHITE CANE DAYS

Throughout the world, the long white cane is used by people who are blind or visually impaired as a tool for safe and reliable navigation. The white cane is a symbol of the user's skills and talents, mobility and



independence. It also allows the sighted person to recognize that the user is visually impaired.

The white cane was initially developed and put into use as a measure of safety, especially in traffic situations. Sufficient training with an Orientation and Mobility specialist can aid in successful cane use, technique and safety. Several countries have traffic laws designed to protect the person using the white cane. The "[VisionAware](#)"

section of the American Foundation for the Blind's website illustrates several types of white canes that are internationally recognized.

Sometimes the white cane has a red band or strip for the purpose of contrast.

International White Cane Safety Day (October 15th) gives Lions

an opportunity to increase awareness of the white cane traffic safety laws. According to the [World Blind Union](#), which is a global organization representing the 285 million blind or partially sighted people worldwide, "White Cane Day is observed worldwide to recognize the movement of blind people from dependency to full participation in society."

Suggested Activities for Lions

Mobilize your club to partner with local blindness experts, schools and organizations for the blind to plan your International White Cane Safety Day awareness activity.

- Arrange for a person who is blind to demonstrate the use of the white cane and its benefits and share his or her accomplishments and aspirations with the community or your club.
- Invite a representative from a local school for the blind or a low vision clinic to speak about white cane, orientation and mobility and white cane laws in your community.
- Work with your local government officials to create a White Cane Safety Day Proclamation for your event.
- Work with local news media to convey your community's white cane laws to the public.
